UK Parliamentary election

for the

North Herefordshire Constituency

1. An Election is to be held for a Member of Parliament to serve North Herefordshire.
2. Nomination papers can be obtained from the office of the (Acting) Returning Officer, Herefordshire Council, Electoral Services, Town Hall, St Owen Street, Hereford, HR1 2PJ during the times stated below.
3. Nomination papers must be delivered to the (Acting) Returning Officer at Herefordshire Council, Electoral Services, Town Hall, St Owen Street, Hereford, HR1 2PJ on any day after the date of this notice, on Monday to Friday 10am to 4pm (excluding bank holidays) but no later than **4pm Thursday, 14th November 2019**.
4. The £500 deposit must be paid by legal tender.
5. If the election is contested the poll will take place on **Thursday, 12th December 2019**.
6. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Tuesday, 26th November 2019**.
7. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Herefordshire Council, Electoral Services, Town Hall, St Owen Street, Hereford, HR1 2PJ by **5pm on Tuesday, 26th November 2019**.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Herefordshire Council, Electoral Services, Town Hall, St Owen Street, Hereford, HR1 2PJ by **5pm on Wednesday, 4th December 2019**.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Herefordshire Council, Electoral Services, Town Hall, St Owen Street, Hereford, HR1 2PJ by **5pm on Thursday, 12th December 2019**. The physical incapacity must have occurred after **5pm on Wednesday, 4th December 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday, 4th December 2019**.
